OFFICIAL STATEMENT No. 1 of 2017

10 May 2017

1. Provincial Conference

The 18th Triennial Provincial Conference will be hosted by Diocese of Kimberly and Kuruman in Kimberly from the 27th September – 01st October 2017, the following must be noted:

- **Conference Theme:** *Journeying with Christ in Challenging Times*
- **Conference Guest Speaker:** The hosting Diocese must source a reputable person from any denomination and inform the Provincial Executive on time when such a person has been sourced and the hosting Diocese must also inform PEXCO if they are not in position of sourcing a Guest Speaker
- **Conference Social Responsibility event:** The hosting Diocese must identify a school which the Guild will donate school shoes and sanitary towels to, the contact details of the nominated school must be communicated to the Provincial Secretary by no later than the 31 July 2017
- **Conference Fee:** R 6 000.00/Diocese (Must be paid by all Dioceses not later than 30 May 2017)
- **Subscription (Subs):** (R30 x no of members in the diocese) payable by no later than 30 July 2017
- **Conference Envelope/Iingxowa:** minimum R 5 000.00 / Diocese (Payable on or before Conference 2017).
- **Conference Package:** Diocesan Reports and confirmation of Conference attendees must be submitted to the Provincial Secretary by no later than 30 June 2017
- **Conference Fundraising:** The Treasury Plenary recommended that the Treasurers of Dioceses of George, Pretoria, Johannesburg, Free State and Kimberly/Kuruman to come up with a fundraising strategy for the Provincial Conference
- **Conference Sponsor:** All Dioceses are urged to source sponsorships, all sponsor request sponsorships when submitted the Provincial Secretary and Treasurer must be copied
- **Service Booklet:** The booklet will be made available in English, Xhosa, Sesotho, Zulu, Venda, Tsonga and Sepedi during Conference in the Diocese of Kimberly and Kuruman
- **Motions and Elections Procedures:** The procedures will be disseminated to all Dioceses by the Provincial Secretary no later than 31 May 2017 for comment and finalization

2. Annual Fee

The Lesotho Provincial Council of 03 – 04 March 2017 has resolved that the Guild will be supporting COTT students with “spending money” and such money is to be paid when Dioceses are paying their Annual Fees in January 2018. The Annual Fee is R 2 000.00 and the spending money is R 1 000.00, which equals to R 3 000.00/Diocese.

3. NPO Registration

The Lesotho Provincial Council of 03 – 04 March 2017 resolved that the Guild abandon any attempts of registering the Guild as an NPO until further notice

4. PEXCO Traveling Costs

The Lesotho PCM was reminded that Provincial Council meetings would be held once a year post Kimberly and Kuruman Provincial Conference. The Lesotho PCM also resolved that the PEXCO that will be elected in KnK must discuss and resolve whether it is financially viable to rotate the PEXCO meetings or not and whether it is necessary to meet twice a year or not.

The Provincial Treasurer has been tasked to compile a comprehensive report that will give a clear analysis on the Guild’s travelling expenditure in the last 2 years, the report must be ready during PEXCO of July 2017.
